The Design

We prepare the design drawings, which are to be submitted for approval based on the standards/ specifications. MAF team design engineers who are proficient in typical fire protection system layouts.

As with the bids, the owner's engineering representative should thoroughly review the design drawings and flow calculations for technical compliance with the specifications. Final documents shall be submitted to the Civil defence (Local Authority for Jurisdiction) for approval after clearance from owner's representative.

Many contractors are not aware of the NFPA standards for specialized designs, such as turbine/generator protection, flammable liquids (storage/handling) and LPG tanks. In such cases, our expertise is available and can be used for the preparation of design drawings. The owner should then go-to-market for a bid for the installation based on our concept design drawings.

The Installation

Only after acceptance/approval has been obtained in writing from all review agencies, installation should begin. The failure to do so could result in major changes to the system that has already been installed. The installer would likely pass those additional costs to the owner. Fire safety practices should be in place during





























installation, including good housekeeping and the proper supervision of hot and cold works. The owner's representative should make periodic progress inspections to check for non-conformance issues and good work practices.

Acceptance Evaluation

Acceptance evaluation of installed fire protection systems includes design and installation verification as well as acceptance testing. A final "walk-down" of the installation by an experienced fire protection specialist ensures that the systems is installed as per final approved design.

The specialist checks to make sure that no unauthorized or non-conforming changes have been made during the installation and that any field changes have been approved. The final verification includes all equipment and supporting devices which include functional tests of the components to prove the integrity of the complete fire detection and protection system.

Acceptance Testing

Even though fire protection systems cannot be tested under actual operating conditions, several steps need to be completed before a system can be considered as reliable and proper. Acceptance testing refers to the non-destructive tests that can be performed to assess the system's ability to meet the established performance criteria.

For water-based systems, this includes pipe flushing and hydrostatic tests, full trip testing of actuating valves and testing of all associated alarms. For gaseous fire suppression systems, this includes a complete operational (trip) test and the release of agent for carbon dioxide and clean agent fire suppression systems. A door fan test (Integrity Test) should be performed to assess the "tightness" of the protected space. Integrated system tests ensure that Fire suppression and detection systems working effectively.

APPLICATIONS

RESIDENTIAL & COMMERCIAL BUILDINGS, HOTELS & RESTAURANTS

The common type of fire fighting systems used in the buildings is automatic wet pipe sprinkler systems. In case of fire, the alarm valves act as check valves and give an alarm. The alarm is usually through the water gong audible alarm bell or through the signal from pressure or flow switch and the fire detection system and alarm system (since these systems are interfaced, as per local laws/regulations).

Pre-action alarm systems which have two signals in order to start water flow through a sprinkler system. It is especially of great use in the case of a false alarm or a mechanical failure. This is recommended in areas where sprinklers are necessary only in case of actual fire, so there is no water damage to any expensive assets in the building, due to inadvertent opening of sprinklers.

OIL, GAS & PETROCHEMICAL

Deluge water spray system for cooling of storage tanks, bullets, spheres, structures and flammable liquid storage areas. Fixed foam system for open top floating and fixed roof flammable liquid storage tanks. Foam bladder tank systems provide accurate, dependable, and cost-effective foam fire protection for a variety of flammable/combustible hazard areas, with no external power other than water pressure. Water is applied to the outside surface of the bladder, displacing foam the concentrate inside the bladder, which then is injected into the water stream. Deluge or compressed foam system for Generator room, Air craft Hangers and flammable liquid storage and handling areas. Custom engineered foam systems are ideal for foam proportioning applications for a range of foam discharge. The different range of Water/Foam monitors are used in petrochemical storage and refineries

MANUFACTURING PLANTS

The danger of Fire is critical in areas of manufacturing like paint booths, flammable liquid and paint storage areas, packing areas comprising of corrugated boxes, woods, boiler/switchgear/generator rooms, exhaust ducts, quench tanks, etc. In such places, fire detection and medium velocity water spray systems are used. Deluge or compressed foam systems are also commonly used in flammable liquid storage and handling areas. Custom engineered foam systems are used in special hazard areas.































POWER PLANTS

Deluge water spray system is commonly used in protecting places with steam gas and turbo generators, operating at high temperature and speed, containing a large quantity of lubricating oil that involve major risk of fire. For protecting any fixed hazards such as transformers, circuit breakers, diesel engines and diesel storage tanks, turbo alternators, lube oil systems, oil filled boilers; high-velocity water nozzle spray is used. Fire detection and medium velocity water spray systems are used in coal conveyor systems.

IRON AND STEEL INDUSTRIES

Iron and steel furnaces and heating chambers involve much fire hazards. The fixed water and foam fire protection system is able to quickly extinguish or suppress the fire and protect the surroundings until relevant personnel have full control of the situation.

AVIATION INDUSTRY AND AIRPORTS

Hangers – where aircraft are kept, are areas of potential risks keeping in mind the significant quantity of flammable liquid, etc. are present. Foam-water deluge systems, with supplementary protection like lowexpansion foam discharge system using water powered oscillating monitors, are used in such places. Another option is a combination of automatic sprinkler protection and an automatic low-expansion foam system.

MARINE INDUSTRY

Taking into account the potential danger in terms of loss of lives and damage to cargo, fire hazard could be serious and crucial in vessels. We have a range of cast bronze monitors and aluminum bronze nozzles to nickel aluminum bronze deluge valves. They are the robust, rugged and very dependable type of firefighting products that are suitable for the marine type of environment.

PORTS AND TERMINALS

Foam —water sprinkler systems are the commonly used in high and medium risk areas in ports and docks like fertilizers, biomass, wooden boxes, chemicals, flammable liquids areas, etc. There are even other various portable foam discharge devices like mobile foam units, trailer mounted monitors are used in terminals.































METRO RAILWAYS

The fire characteristics in a metro tunnel are unique, different from those in buildings. The main fire load in a metro tunnel is the train itself and there is likelihood for the fire to spread along the cabin cars due to the effects of fire in the confined space. Unlike building fires, a train may still be in motion within a tunnel and the air in the tunnel may also be flowing due to the operation of the mechanical ventilation system. The consideration of fire safety in rail and in tramps, it has been increasing over recent years at a rapid rate. There are many steps of the requirement for fire protection that must be followed by metro rail operators. All systems including passenger compartments, electrical systems and switch cabinets pose lots of considerations for fire protection system during installation. With rail tunnel development booming worldwide, fire protection and safety measures have come to the forefront once again. With key technologies such as reaction-to-fire properties of rolling stock, fixed gas suppression systems, improved fire detection systems including video-based automatic incident detection systems and the automatic deployment of preset emergency plans, the industry tries to minimize the danger of tunnel fires.
